RESOLUTION NO. 49-2003

Upon a motion by Representative Allen Pemberton and second by Representative Richard Barrett, Sr., the following was enacted:

WHEREAS, the Red Lake Tribal Council is the duly elected governing body of the Red Lake Band of Chippewa Indians; and

WHEREAS, the Tribal Council is interested in offering opportunities to Band members to harvest Band resources in a biologically sustainable manner; now

THEREFORE BE IT RESOLVED, the Red Lake Tribal Council hereby authorizes angling for fish species other than walleye through the 1st Saturday in April on the reservation waters of Red Lake; and

BE IT FURTHER RESOLVED, all ice shelters which include dark houses, fish houses, and portable shelters placed on the ice of the Red Lake Indian Reservation must have complete name and mailing address displayed and clearly visible on the outside of the shelter.

BE IT FURTHER RESOLVED, all ice shelters must be removed from the ice no later than the 2nd Saturday of March. Portable ice shelters may be used after this date, but must be removed daily.

BE IT FURTHER RESOLVED, if fish are filleted before transport, skins must be kept on the fillets for clear identification of the fish.

BE IT FURTHER RESOLVED, the Red Lake Conservation Department has the authority to close the ice fishing season early if ice conditions become unsafe.

BE IT FINALLY RESLOVED, this resolution amends Tribal Resolution 82-84 and Tribal Resolution 57-2002.




